

## Professional Development for Group Training Staff Certificate IV in Work Health and Safety- BSB41415 Upgrade from BSB41407 Cert IV in OHS

AEN is offering the Cert IV in WHS to Group Training staff who are interested in gaining knowledge and skills in:

- Assisting with compliance with WHS laws
- Identifying hazards, assessing and controlling risks
- Monitoring workplace safety
- Managing consultation and participation processes
- Assisting with claims, rehabilitation and return-to-work programs

The course will be delivered by **Holmesglen Institute** through a combination of targeted workshops, on the job delivery, project based learning followed by one-on-one support through coaching and mentoring.

The program will be offered to staff who need to complete the entire qualification as well as to those who are interested in upgrading their old Cert IV in OHS and therefore understanding the legislative and practical changes that occurred in relation to health and safety.

### Training Delivery Format

Students will be required to present evidence of completion of relevant Units of Competence for Credit Transfer to be considered. It is anticipated that up to five UOC may be considered for this process.

3 UOC (see below) will require students to attend classroom based workshops, joining in with the students who complete the full qualification. 2 UOC (BSBWHS406 and PUAWER002B) will be trained and assessed at the student's worksite.

### Recognition of Prior Learning (RPL)

All students will be offered the opportunity to participate in a Recognition of Prior Learner process if they believe that they have suitable experience and knowledge to be assessed as competent in any UOC. The student will be required to provide the required evidence to determine suitability.

### Classroom based workshops

The dates for the training are as follows:

24 Aug	BSBRES401 - Analyse and present research information
23 Sep	BSBWHS405 - Contribute to implementing and maintaining WHS management systems
13 Oct	BSBWHS407 Assist with claims management, rehabilitation and return-to-work

### Assessments

Assessments will be a mixture of practical demonstration, written and theory assessments, oral, research projects and workplace tasks.

All competency units are assessed as **Off the Job** (assessment of knowledge through classroom assignment tasks), **On the Job** (assessment of skill demonstrated while on site) and **On line** (completion of assessment, projects, quizzes).

The completion of the course is expected to be 25 November 2016.

### Course fees

All students will be subject to the funding eligibility test. Generally, this means that a student who holds an equivalent or higher qualification (Cert IV) or has accessed funding for training on two previous occasions would be not be eligible for funding.

However, the Victorian Government is currently offering funding to ineligible students through Victorian Training Guarantee (VTG) exemptions. Note: Only students residing in Victoria are eligible for VTG funding.

Non-eligible students (FFS)	\$1840 pp + GST
