# About the videos

## Australian Apprenticeships - My Gain Videos

The AAT Information Service has created an avenue for Australian Apprenticeships support services to further market Australian Apprenticeships through published videos on the Service's YouTube channel, Australian Apprenticeships - My Gain [www.mygain.com.au](http://www.mygain.com.au).

The main aim of creating and managing a YouTube channel is to have a central library consisting of visual media relating to:

- Occupations that can begin with an Australian Apprenticeship; and
- Australian Apprenticeships support services available, and what their roles are.

The AAT Information Service works with organisations to film occupational and organisational videos using Smartphones or video cameras, and edits the videos to include the organisation's branding before they are published on the Service's YouTube channel.

As well as being publically available on YouTube, videos may be listed in the 'Career Resources' section on both the [www.aatinfo.com.au](http://www.aatinfo.com.au) and [www.aapathways.com.au](http://www.aapathways.com.au) websites, attached to the relevant organisation within the 'Service Provider Search' feature, attached to an appropriate Sample Training Program or Sample Job and Training Description within these websites, and published on other apprenticeship and traineeship related websites.

All videos are edited and managed by the AAT Information Service.

## The AAT Info Service

The Australian Apprenticeships and Traineeships Information Service or 'AAT Info Service' provides information on potential Australian Apprenticeships pathways and a range of associated resources.

This free service, funded by the Australian Government Department of Education and Training, provides information and resources used by staff in organisations implementing Australian Apprenticeships and by job seekers, students, career advisers and employers.

This site provides detailed information on potential Australian Apprenticeships based on training package qualifications and is targeted at people working in Australian Apprenticeships related networks.

This site allows employers, jobseekers, students or parents to self-search for information and can also be used by support service staff as a base for their Australian Apprenticeships conversations with these groups.

This channel includes many apprentice, trainee and employer video interviews to help jobseekers and students get ideas on different occupations and how to approach job hunting in a range of industries.

# **Video requirements**

In most cases, the AAT Information Service will film the Australian Apprenticeships - My Gain videos, however an organisation may get approval to film interviews themselves provided that they follow the below requirements, and collect the appropriate consent forms (provided on page 5 and 6).

Using a Smartphone or video camera to film a video might sound simple enough but there are a few things that you should take into consideration such as sound, lighting and camera stability, to ensure that you send the AAT Information Service the best quality video you can.

## **Do's**

- Film all videos in landscape orientation;
- The video length should be between 1.5 minutes and 3 minutes;
- The interview video should capture the upper torso of a participant without using zoom;
- Review the whole interview video whilst with the participant so that if there are errors with the sound or picture quality you can re-shoot it with the participant then and there.

## **Don'ts**

- Don't influence the participants answers. The interview should be as 'natural' and honest as possible;
- Do not film in a noisy area;
- Do not get vehicle license plates or other personal identification objects or documents in the background of the video (passing cars are okay);
- Do not film if there is evidence of a breach of Workplace Health and Safety regulations (check the background thoroughly).

## **Tips and Tricks**

- Film the interview within an office or an outside space with minimal background noise (no wind or loud machinery);
- Try to hold the Smartphone or video camera as still as possible, or use a tripod or brace;
- Make sure that the phone or video camera is close to the interviewed participant to pick up the audio;
- Try to film away from the sun to help eliminate over-exposure;
- Let the participant look through the interview questions before you begin filming and explain the time limit they need to be conscious of;
- Ensure that your fingers do not cover your camera's microphone. This can result in 'muffled' audio which the AAT Information Service will not be able to use.

## How to send videos to the AAT Information Service

Once you have filmed and proofed the video interviews, you will need to send them to the AAT Information Service.

There are a number of ways to send your finished videos:

Please send an accompanying message explaining how many videos you are sending through and include your contact details.

You will also need to make sure that you send through a scanned copy of the signed media releases (page 7 and 8).

Media releases are necessary to be able to publish media in which an individual or an organisation is included. Without these signed media releases, the AAT Information Service is not able to publish the video.

# Interview questions

Hi \_\_\_\_\_ . Thanks for chatting to us today.

**Can you tell me what qualification/occupation you are in?**

*“Hi, my name is XXXX and I am an apprentice electrician, currently studying a Certificate 3 in Electrotechnology”*

**How did you start out in this occupation? Or How did you find this job/apprenticeship/traineeship?**

*“I saw an advertisement for an apprenticeship in the local paper, applied and got the job. I started the next day.”*

**What are your routine day to day tasks and what is the most enjoyable part of the job?**

*“My normal workday includes...”*

**What do you want to do when you finish you apprenticeship/traineeship?**

*“I plan to continue my studies and one day, become a manager of my own business.”*
