
## AEN Office Facilities

# Hosted Learning Management System

AEN offer a fully managed hosting platform to get you started in the world of e-Learning.

The AEN LMS is based on the open source Moodle package that is widely used nationally and internationally by RTOs, TAFEs and Universities.

AEN use our own LMS through this platform for staff and professional development training for the AEN network.



Benefits of AEN hosting your LMS include:

- Full administration control of your training portal
- Learning management and reporting systems
- Student usage reports, eg. Time spent, assessment attempts, etc.
- Online discussion boards and live chat

- Ability to upload videos / recording / powerpoint presentations etc.
- Assessment / meeting scheduling
- Flexibility to move your course content to another server
- Hosted on a Tier 1 VPS to maximise speed and reliability
