
## Introduction

The Victorian Government and the Apprenticeship Employment Network (AEN) as the peak body representing group training organisations are committed to maximising employment / apprenticeship / traineeship opportunities for local communities. As part of this commitment, organisations seeking Victorian registration as a GTO - and would like a letter of support from the AEN - are required to provide a statement of industry impact as part of the application process. This statement is aimed at enabling organisations to outline how their proposed supply of goods/services will provide a positive impact on the existing local industry.

Your GTO industry impact statement will be used by the AEN to determine potential AEN membership and what level of support AEN will provide to your application to the VRQA.

## Industry Impact Statement

The industry impact statement allows a proposed new GTO application the opportunity to provide comment on how your application will positively affect the existing GTO industry/economy. You will need to ensure you can verify the information you submit and where possible should provide actual numbers of staff/values of goods and/or services in your statement.

It is the applicant's responsibility to ensure that sufficient information is supplied so that AEN is provided with a clear understanding of the proposed business scope, long-term sustainability and market entry strategy.

Example guidelines for your Industry Impact Statement
